This coming week, Legacy's Education Committee will host the first session of a twopart live webinar to present the history of Indianapolis centered on the message that has become synonymous with the Indy story: "Never give up!"

Guest presenters will include *Indianapolis* survivors Dick Thelen and Edgar Harrell; lost-at-sea family members Earl Henry and Michael William Emery; Jane Goodall, daughter of rescue pilot Chuck Gwinn; Captain Bill Toti, retired skipper of Indy's namesake submarine (SSN-697); and Sara Vladic and Lynn Vincent, authors of the 2018 *NYT* bestselling book, *Indianapolis*.

#### **Election Bylaws**

Bonnie Buckett and Legacy's Bylaws Committee identified an issue with the initial terms of office for board members that was written into Legacy's bylaws at the group's founding in 2018. According to the initial bylaws, the terms of three of five board members would expire every four years.

In order to promote better continuity of leadership, the Bylaws Committee is proposing changes to the terms of office for two board members, Vice Chair and Member at Large. Under the current bylaws, the Vice Chair serves for three years and the Member at Large for two. Under the proposed change, the Vice Chair's term would be reduced to two years and would match the existing two-year term for the Chair.

In this way, the terms of the Chair and Vice Chair would expire in alternating years, providing for greater continuity. Additionally, the proposed change would extend the term of office for the Member at Large from two years to three. By making these two changes, the number of new board members whose terms expire simultaneously would be reduced from three to two for each election cycle. Because this proposal would alter the bylaws, the entire Legacy membership must vote on the change.

Meanwhile, Survivor James Smith reluctantly shared that he went AWOL three times before he was caught and sent to the brig after returning late from a date with a young lady. ("It was worth it," James said.)

What better way to earn money for college than by telling your family's story? The application period for the USS Indianapolis/Gwinn "Angel" Scholarship is now open through March 31, 2021. #### Requirements include:

• Applicant must be a descendant (including stepchildren) of a survivor, honorary survivor, lost at sea (LAS) or rescue crew.

- Attend or be a prospective full-time attendee of an accredited 2 or 4-year college or university.
- Academic performance including GPA will be considered. A GPA of 3.0 and above is preferred.
- A copy of your most recent transcripts.
- Two essays are required for this scholarship.
